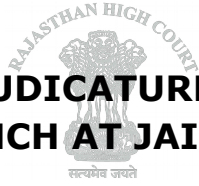

**HON'BLE MR. JUSTICE CHANDRA KUMAR SONGARA**

**Order**

**11/08/2023**

These bail applications have been filed under Section 439 of Cr.P.C. in connection with FIR No. 233/2023 registered at Police Station Dadabari, District Kota for the offences under Sections 341, 323, 354, 379, 307 & 34 of IPC.

It is submitted by learned counsel for the petitioners that the petitioner- Noor Bano is a lady of 45 years of age and the petitioner-Jakir Hussain is 31 years of age. Both are behind the



bars since 08.07.2023 and they have no criminal antecedents.  
Hence, the accused-petitioners may be released on bail.

Learned Public Prosecutor has opposed the bail applications.

Heard and perused the material available on record.

As per injury and X-ray reports of Seema, Geeta and Ashok,  
all injuries are simple in nature.

Considering the submissions made by learned counsel for the  
petitioners and taking into consideration overall facts and  
circumstances of the case but without expressing any opinion on  
the merits/demerits of the case, this court deems it just and  
proper to enlarge the petitioners on bail.

Accordingly, these bail applications under Section 439 of  
Cr.P.C. are allowed and it is ordered that the accused-petitioners  
Noor Bano W/o Gaffar Ali and Jakir Hussain S/o Gaffar Ali shall be  
enlarged on bail; provided each of them furnishes a personal bond  
in the sum of Rs.50,000/- with two sureties of Rs.25,000/- each to  
the satisfaction of the learned trial Judge for their appearance  
before the Court concerned on all the dates of hearing and as and  
when called upon to do so.
