With full confidence at her command, the corpus stated that she was maltreated by her husband Loonkaran Singh R/o Village Ransi and thus she came and started living at her father's house at Village Ramdawas. Thereafter, she came into touch with one Sumer Singh and went with him of her own free will and volition. Now after being traced out, she expresses her desire to live at her father's house with her child. She apprehends some harm to his child by Loonkaran Singh and his family members.

We, therefore, direct the SHO, PS Pipar City to ensure the security of the corpus and her child. She shall be safely escorted to her father's house.

The Habeas Corpus Petition is disposed of. The rule is discharged.
