Heard. While disposing of this appeal, we had imposed a penalty of Rs. 40 Lakhs on the premise that the appellant is liable to pay Rs. 25 Lakhs as a trading member and Rs. 15 Lakhs as a clearing member. On the last date of hearing, Mr. Kunal Katariya, learned advocate for the appellant / review applicant submitted that the upper limit of penalty must be Rs. 15 Lakhs. Learned advocate for the respondent had sought time to complete the instructions.

2. Today, on instructions, Mr. Sameer Pandit, learned advocate for the respondent fairly submitted that the maximum penalty shall be Rs. 25 Lakhs. His submission is placed on record. Order dated November 28, 2025 is modified accordingly. Remaining portion of the order remain undisturbed.

3. In the result, total penalty is reduced to Rs. 75 Lakhs. In the event, appellant is entitled for the refund, it shall be made within an outer limit of two months from today.

4. Review Application is disposed of.
