		<p data-bbox="300 450 1224 536">in relation to the lotteries until the disposal of the Appeal.</p> <p data-bbox="295 581 1247 1389">After hearing learned Counsel for the parties, we do not consider it to be a fit case where we should stay the operation of the impugned order dated 29th April, 2000 passed by the learned District Judge, Special Division, Gangtok and restrain the respondents from using the 77 trade marks in relation to its lotteries. If any order of stay as prayed for by the appellant is granted, and in case the appeal is dismissed, the State will lose its revenue only on account of the order of the Court.
