WANGDI, JUDGE Present: Mr. Zangpo Sherpa, Advocate with Mr. Dewen Sharma and Mr. Sangay Gurmey Bhutia Advocates for the Petitioner. ----- Since in Crl.Rev.P. No. 8 of 2015 out of which this application arises, the impugned order of the Sessions Judge, Special Division-II, East Sikkim at Gangtok, in Criminal Appeal No. 5 of 2013, has been stayed, the order of sentence shall remain suspended until further orders. In the facts and circumstances, the Accused/Petitioner is enlarged on bail on the following terms and conditions: (i) The Accused/Petitioner shall not leave station without the leave of the Court of the Chief Judicial Magistrate, East & North Sikkim, at Gangtok; (ii) He shall furnish a bond of Rs.50,000/- (Rupees fifty thousand) with a local security to the like amount .
