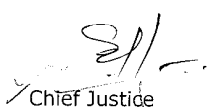

SINHA Present: Mr. Thupden G. Bhutia, Advocate for the Appellant. Heard. Mr. Bhutia submits that the deceased was the owner of the vehicle; he himself was driving the vehicle at the time of the accident; the policy was comprehensive, which covers the risk of owner-cum-driver to the extent of Rs.1.00 lakh only, whereas the Tribunal has awarded Rs.22,66,979/-; the Claim Petition was filed under Section 166 of the Motor Vehicles Act, in which the Tribunal recorded the findings that there was a contributory negligence, but no other vehicle or person was involved in the accident, therefore, there was no question of contribution by any other party. Issue notice to the Respondents. Steps within seven days. List for further orders on 11.08.2015.
