The District Collector, East at Gangtok has filed an affidavit dated 16.09.2015 stating therein that after submission of the survey reports, the matter pending before him has been disposed of on 11.09.2015 and the purcha khatian has been duly rectified by recording Plot No. 113 in the name of Chattrra Singh, Son of Dhan Bahadur, Caste - Chettri. A copy of purcha khatian has also been annexed (Annexure A-1) with the affidavit. The above facts have not been disputed by Mr. Zangpo Sherpa. He submits that the grievance raised by the Petitioner in this Petition has been addressed and nothing survives for adjudication by this Court.
