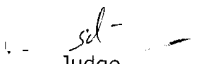

Pursuant to our notice dated 25.07.2016, the State has filed an Affidavit on 02.09.2016, wherein it was stated that the work of laying the road, after completing Jhora Training Work, would be initiated immediately after approval and financial sanction. The State has filed a Progress Report on 24.10.2016 submitting that the Jhora Training Work has already commenced on 23.09.2016 and the same will be completed by the end of this month. Thereafter, having regard to the area involved, which according to the Learned Senior Government Advocate is 30 metres, more time is not required. It is expected that by the end of November, 2016, the complete laying of the road including the Jhora Training Work would be completed.
