Learned counsel appearing for the respondent states that he has already moved an application seeking withdrawal of the case being H.M.P. No. 134 of 2019 titled Kamal Mohanlal Khilwani versus Priti @ Riya Kamal Khilwani pending before the Civil Judge, (Senior Division), Hinganghat, Maharashtra, in respect of which the petitioner has sought transfer, and that the respondent has already filed a petition seeking divorce at Indore. According to him, no order is being passed on the proceedings of the said case as the proceedings are stayed by this court. Learned counsel for the petitioner also does not dispute the said position.

In view of the above, the stay of the proceedings being HMP no. 134/2019 granted by the Hon'ble Court vide

order dated 31.01.2020 is vacated. The concerned Civil Judge, (Senior Division), Hinganghat, Maharashtra, is directed to pass appropriate orders on the withdrawal pursis filed by the respondent.

In view of the above directions, the present transfer petition would not survive and stands disposed of accordingly.
