The petitioner (wife) seeks transfer of the petition in terms of the prayer which is inter-alia, as follows:-

(i) Pass an order transferring petition under Section 9 of the Hindu Marriage Act, 1955 being Petition A/1579/2019 pending before the Family Court, Nagpur II titled as Umesh Udal Verma vs. Mrs. Tripti Umesh Verma for restitution of conjugal rights to the Family Court in Lucknow, Uttar Pradesh or any other court in Lucknow, Uttar Pradesh, otherwise great prejudice and hardship will be caused to the petitioner.

We have heard the learned counsel for the petitioner. Though served there is no appearance on behalf of the respondent (husband).

We see no reason why we should not allow the transfer petition. Accordingly, the transfer petition is allowed. The Petition A/1579/2019 titled as "*Umesh Udal Verma vs. Mrs. Tripti Umesh Verma*" pending before the Family Court, Nagpur II, is ordered to be transferred to Family Court in Lucknow, Uttar Pradesh.
