1. During the pendency of the matters before this Court, the instant application has been filed by the applicants seeking bail. The hearing of the

appeal(s)/petition(s) would take some more time and as such, the application seeking bail is taken up for consideration.

2. Heard the learned counsel for the applicants as also the learned counsel for the respondent-State and perused the application papers.

3. A perusal of the custody certificate would indicate that two of the applicants/convicts before this Court in SLP(Crl.) No.9314 of 2017 namely *Raju and Bisahu Patel*, have served sentence of more than 09 years and the other applicant/convict namely *Rajulal* in SLP(Crl.) No. 9316 of 2017, has served sentence of more than 13 years as on date.

4. In that view, taking into consideration all aspects of the matter, and subject to appropriate conditions being imposed by the Trial Court, we deem it appropriate to direct that the applicants herein be enlarged on bail.

5. For the purpose of imposing appropriate bail conditions and for the issue of release orders, the applicants shall forthwith be produced before the Trial Court namely, 7th Additional Sessions Judge, Raipur (C.G.) in Sessions Trial No. 418 of 1996.

6. Ordered accordingly.
7. The application is accordingly disposed of.
