These Review Petitions arise out of the decision of this Court dated 23.03.2021.

Applications for grant of oral hearing are rejected.

The principal submission advanced in the instant Review Petitions is

pertaining to the decision of this Court in *Ghaziabad Development Authority vs. Kashi Ram and others* [Special Leave Petition (Civil)No. 5815 of 2015] wherein compensation @ Rs.297/- per square yard was awarded.

The tabular chart in paragraph 34 of the decision dated 23.03.2021 had *inter alia* referred to the rate awarded in *Ghaziabad Development Authority vs. Kashi Ram and others*.

All the submissions advanced by the learned counsel for the parties were taken into account after which it was concluded by this Court that the compensation awarded by the Reference Court was quite correct.

We have gone through the grounds raised in the Review Petitions and do not find any error apparent on record to justify interference.

These Review Petitions are, therefore, dismissed.
