Heard learned counsel for the parties.

In deference to the suggestion given by the Court, both the parties have agreed to reschedule the payment schedule in respect of installments dated 15.04.2020 and 15.06.2020 respectively as 10.07.2020 and 10.08.2020 respectively. Rest of the payment schedule to remain as it is.

It is pointed out by the applicant/appellant that an amount of Rs.20,00,000/- (Rupees Twenty Lakhs) has already been made over to the opposite party against the payment schedule dated 15.04.2020. If so, that amount be adjusted in the second installment, namely, which was due on 15.06.2020 now payable on 10.08.2020.

In other words, the outstanding dues payable on 15.04.2020 and 15.06.2020 will now be paid in the following manner:

- (i) Rs.1,50,00,000/- (Rupees One Crore Fifty Lakhs) on or before 10.07.2020 alongwith interest at the rate of 10% per annum for the delayed period (i.e. 15.4.2020 until payment); and
- (ii) Rs.1,30,00,000/- (Rupees One Crore Thirty Lakhs) on or before 10.08.2020 alongwith interest at the rate of 10% per annum for the delayed period (i.e. 15.6.2020 until payment).

All other payment schedule dates shall remain unchanged/undisturbed.

The misc application is disposed of accordingly.
