b) Transfer AO (Appeal) bearing No.17/2020 filed by respondent-Sh. Arun Rawat (husband), pending before the Hon'ble High Court of Uttarakhand having cause titled "Arun Rawat Vs. Suneeta Miyan Rawat may also be transferred to Delhi High Court.
