O R D E R

1. Leave granted.
2. The amount covered by the cheque along with interest at the rate of 6% i.e. Rs.3,66,000/- (Rupees Three Lakh Sixty Six thousand only) has been tendered in Court by means of bank draft payable to respondent No.2 [Eagle Express Logistics (India) Ltd.].
3. In view of the aforesaid payment, we find no good reason to permit the criminal proceedings against the accused-appellant to continue. The amount tendered in Court by means of the bank draft be handed over to the learned counsel for the respondent No.2. Proceedings pending against the accused-appellant i.e. CC. No.16156 of 2016 pending in the Court of Ms. Priyanka Rajput,

learned MM, Rohini Courts, New Delhi shall stand quashed.

4. Consequently and in light of the above, order of the High Court is set aside and the appeal is allowed.
