Ms. Charu Mathur, learned counsel appearing for the appellant submits that in this case the High Court has reversed the trial court's acquittal order and has convicted the accused for murder and sentenced him to life imprisonment.

The appeal was dismissed by this Court as the appellant had failed to surrender but the counsel submits that accused has since then surrendered on 03.03.2020 and is currently incarcerated in the Central Jail, Jodhpur.

In view of above and the custody certificate produced on behalf of the accused, the delay of 269 days in filing application for restoration is condoned. Accordingly, the Criminal Appeal D. No.46826 of 2018 is restored to its original number.

The Applications for exemption from filing attested/notarized affidavit, original custody certificate and original vakalatnama stand allowed.

MA No.1187 of 2020 stands disposed of accordingly.
