O R D E R

The marriage between Khushboo Garg (Jain)-Petitioner and Varun Jain-Respondent was solemnized on 09.02.2019. Thereafter, there was a matrimonial discord leading to criminal cases being filed by the Petitioner. The Respondent filed an application for divorce under Section 13 (1)(a) of the Hindu Marriage Act, 1955 before the Family Court, Shivpuri, M.P. The Petitioner-wife filed an application for transfer of the divorce proceedings from Family Court, Shivpuri, M.P. to Family Court, Gurugram, Haryana.

During the pendency of the transfer petition, the parties have resolved their disputes and entered into an agreement on 08.03.2021. The said agreement is taken on record.

According to the agreement, the respondent would pay the Petitioner an amount of Rs.40 Lakhs towards maintenance, alimony and other miscellaneous expenses. An amount of Rs.20 Lakhs has been paid by the Respondent-husband to the Petitioner-wife in March, 2021. The

Respondent-husband undertakes to transmit the remaining amount of Rs.20 Lakhs today i.e. 27.08.2021 to the Petitioner-wife. The parties undertake to withdraw all the civil/criminal cases filed against each other at the earliest.

In the facts and circumstances of this case, the cooling-off period of six months for dissolution of marriage is waived.

In view of the settlement reached between the parties, the marriage between the Petitioner and the Respondent shall stand dissolved by a decree of divorce with mutual consent. A decree may be drawn accordingly.

With these observations, the transfer petition stands disposed of. Pending application(s), if any, shall also stand disposed of.
