2. This Court while issuing the notice on 04.05.2017, passed the following interim order:

“Issue notice.

The interim order passed in this case will not affect the order passed in W.P.(C) No.244 of 2017.

The students who have been admitted, their applications can be forwarded for the common counseling, as directed in W.P.(C) No.244 of 2017. If the students, who have been admitted by the University, when their applications are sent to the Common Counseling Committee and they are selected on merits by the said Committee, they will be allowed to continue in the University and prosecute their studies.

3. A period of almost 8 years has passed from the date on which the said order had been passed by this Court. In that view of the matter, without going into the merits of the matter, we dispose of these petitions in terms of the interim order dated

04.05.2017.

4. Needless to say that the said interim order shall not be treated as a precedent in any other matter.
