Heard the learned counsel appearing for the petitioner. As per the report submitted by the Supreme Court Mediation Centre, the mediation has failed. Therefore, the petition is taken up for hearing. A petition for restitution of conjugal rights filed by the petitioner-wife is pending before the Family Court at Sirohi, Rajasthan. A Petition filed by the respondent-husband for divorce filed in the Family Court at Hubballi (Dharwad) is sought to be transferred to the Family Court at Sirohi, Rajasthan.

The petitioner is a resident of Sirohi in Rajasthan and the respondent is a resident of Hubballi, Karnataka.

After having heard the learned counsel appearing for the petitioner and the learned counsel appearing for the respondent, I find that a case is made for passing order of transfer.
