UPON hearing the counsel the Court made the following
O R D E R

Pursuant to order dated 12th January, 2024,
Shri Shibashish Misra, learned counsel has filed the
Interim Mediation Report dated 20th April, 2024, a

copy of which has been provided to us in Court.

In the said Interim Report, Shri Mishra has requested that two directions would be required to be issued, one to the Tehsildar, Berhampur and the other to the Sub-Registrar, Berhampur.

The said directions as requested are reproduced hereunder :

"A direction may be issued to the Tahasildar, Berhampur, Odisha to measure the lands as mentioned in FIR No. 55 dated 22.08.2009(Annexure P1 at Pages 20 to 49) purported to have been sold by the Petitioner through an Amin, in the presence of the Petitioner and the Respondent No. 2 (the Complainant); and

2. A direction may be issued to the Sub-Registrar, Berhampur to submit a report before this Hon'ble Court indicating the valuation of the land in question, on the basis of the report of the Tahasildar, Berhampur, Odisha as mentioned herein above."

It is further stated by Shri Mishra that there is every likelihood that the disputes between the parties could be settled, as the interactive sessions which were held, indicated so.

Accordingly, we issue the directions, as requested by Shri Mishra and as stated above, to the authorities, the Tahasildar and Sub-Registrar,

Berhampur, Odisha to provide all assistance to Shri Mishra and provide the necessary information and documents within a period of four weeks from the date of receipt of the copy of this order being provided by Shri Mishra. List thereafter.
