Mr. Shibashish Misra, learned Mediator has
submitted a '*Second Interim Mediation Report*'. In
paragraph 4 of the said report, it is stated that

with respect to the valuation as determined by the Tehsildar, objections were raised, as such the learned Mediator required the Tehsildar to deal with the same. However, he was informed that the earlier Tehsildar had since been transferred and a new incumbent has come in his place.
