UPON hearing the counsel the Court made the following
O R D E R

Heard Mr. Z.U.Khan learned counsel for the petitioners
and Ms. Garima Prashad, learned senior counsel for the State of
U.P.

Petitioners are claiming for premature release, who are
convicted for life imprisonment. Paragraph 2(b) of the amended
Policy dated 28th July, 2021 reads as under:

"2(b) Such male convicted prisoners sentenced to
imprisonment for life and are incarcerated in prison,
whose crime is not covered by any of the sub-rule under
prohibited category defined in para-3 below and who
have completed age of 60 years and have undergone,
including under trial custody, sentence of 16 years
without remission and 20 years with remission."

Learned senior counsel appearing for the respondent-State, on instructions, submits that now the respondent(s) authorities have decided to re-consider the claims of the petitioners for premature release without reference to the age restrictions imposed in the revised policy dated 28th July, 2021 under paragraph 2(b).

In view of the statement made, we direct the respondents to re-consider the claims of the petitioners for premature release without reference to Clause 2b of the Policy dated 28th July, 2021 and pass appropriate orders within a period of six weeks from the date of receipt of this order and communicate the same to the petitioner.

List the matter after eight weeks.
