UPON hearing the counsel the Court made the following
O R D E R

Pursuant to our order dated 17th August, 2021, a sealed cover containing Mediation Report dated 12th November, 2021 reporting the amicable settlement of disputes between the parties through Settlement Agreement dated 30th September, 2021 has been produced before us containing the terms of settlement.

Learned counsel appearing on behalf of the legal heirs of deceased respondent No.1 submits that an understanding has already been arrived at between the three legal heirs of deceased respondent No.1 by way of Memorandum of family settlement dated 29th August, 2016 in which legal heir (1.3) i.e. *Mr. Devinder Singh Mavi* of respondent No.1 has been authorised to contest the instant litigation (copy of which is produced along with IA No.152098 of 2021 - application for permission to place on record additional documents on behalf of respondent No.1).

Having heard learned counsel for the parties and in terms of the family settlement, legal heir (1.3) of deceased respondent No.1 is permitted to enforce the terms of Settlement Agreement dated 30th September, 2021.

The Special Leave Petitions are accordingly disposed of in terms of the Settlement Agreement 30th September, 2021 which shall form part of this record.

We place on record our appreciation for the efforts made by the learned mediator in assisting the parties to arrive at an amicable settlement.

Pending applications also stand disposed of.
