O R D E R

Heard learned counsel.

On 16.01.2019, following order was passed by this Court:

"Issue Notice, returnable in four weeks.
Dasti in addition, is permitted.
Pending further consideration, there shall be stay
of arrest of the petitioners in connection with
FIR/Cr No.325/2017, Koregaon P.S., Koregaon,
Dist. Sitara dated 11.11.2017."

We have gone through the allegations made in the complaint and having considered the entirety of the matter, in our view, the petitioners are entitled to protection under Section 438 Cr.P.C..

We order accordingly and direct, in the event of arrest of the petitioners in connection with the aforesaid FIR, the Arresting Officer shall release the petitioners on bail on furnishing cash security in the sum of Rs.20,000/- each with two other sureties in the like sum.

Needless to say that the petitioners shall extend cooperation during investigation into the matter and shall remain present as and when their presence is requisitioned by the Investigating Officer. In case, there is no cooperation on part of the petitioners, the facility of anticipatory bail may be recalled.

The special leave petition is disposed of.

Pending applications, if any, shall also stand disposed of.
