Learned counsel submits that the order passed by the Chief Controlling Revenue Authority, Maharashtra State, Pune, confirming the order dated 11.11.2005 passed by Joint District Registrar (Class I) and the Collector of Stamp was under challenge in the Writ Petition.

The Writ Petition was dismissed.

Being aggrieved by the dismissal, the Civil Appeal was filed in this Court. The learned counsel submits that during the pendency of the appeal, the appellant paid the deficit stamp duty as such the challenge in the appeal no more survives.

Accordingly, the applicant/appellant prays for withdrawal of the Civil Appeal. Application allowed.
