This transfer petition has been filed by the petitioner-wife under Section 25 of the Code of Civil Procedure, 1908 seeking transfer of Matrimonial Petition No. 913 of 2018 titled as "Mr. Amitkumar Ramchandra Singh Vs. Mrs. Nitu Amitkumar Singh", pending before the Civil Judge (S.D.) Link Court, Bhivandi, Maharashtra to a Court of competent jurisdiction at Principal Family Court, Hazipur (Vaishali), Bihar.
