Chetna Verma" and Miscellaneous Civil No. 7290/2019 filed by the petitioner titled as " Chetna Verma v. Udit Verma", pending before the Principal Judge, Family Court, Ghaziabad, Uttar Pradesh to the Family Court at Bhiwani, Haryana.

2. In that light, taking into consideration the grounds taken in the transfer petitions to seek transfer, the Petition no. 2283/2019 titled as " Udit Verma Vs.
