ORDER

This petition is filed under Section 25 of the Code of Civil Procedure, 1908, seeking transfer of **O.P. No. 89/2020** titled as “**Swapnil Varier Vs. Remya**” from the Family Court at Thrissur, Kerala to the Court of Civil Judge, Senior Division, Pune, Maharashtra.

Notice was issued in the matter on 18.06.2020. Office Report dated 28.11.2022 indicates that the respondent was duly served, but no one has filed Vakalatnama on his behalf till date.

Having heard the learned counsel for the petitioner and having considered the facts and circumstances of the case, we deem it fit and proper to allow this transfer petition. Accordingly, **O.P. No. 89/2020** titled as “**Swapnil Varier Vs. Remya**” is ordered to be transferred from the Family Court at Thrissur, Kerala to the Court of Civil Judge, Senior Division, Pune, Maharashtra.

The parties shall record their presence before the Transferee Court on 09.01.2023.

Let the record of the case be transferred to the transferee court without delay and intimation be sent to both the courts through e-mail for compliance.

It shall be open to the parties to explore the possibility of an amicable settlement through Mediation before the Transferee Court.

The parties are at liberty to participate in the proceedings either physically or through virtual mode with prior permission of the Transferee Court.

The Transfer Petition is accordingly allowed.
