Heard learned counsel for the parties.

Learned counsel for the respondent contends that in view of the given situation there was a problem in raising funds and thus he sought earlier extension of time which was granted for a period of three months but even in that period of time only Rs.20,00,000/- (Rupees twenty lakhs) has been deposited out of a total of Rs.1,40,00,000/- (Rupees one crore and forty lakhs).

We are of the view that since the respondent is now seeking another two months' time to make the payment, the interest will be payable @ 6% simple interest on the balance amount of Rs.1,20,00,000/- (Rupees one crore and twenty lakhs) for the complete period from 1<sup>st</sup> May, 2020 and on the amount of Rs.20,00,000/- from 1<sup>st</sup> May, 2020 to the date of deposit. We make it clear that no further extension in this behalf shall be considered. Applications stand disposed of.
