ORDER

- 1 The transfer petitions have been filed by the petitioner – wife for transfer of the following proceedings:
 - (i) Matrimonial Case No 469 of 2019 titled “Amit Chauhan Vs Aarti Devi” from the Court of Principal Judge, Family Court at Mainpuri, Uttar Pradesh to the competent Court at Valsad, Gujarat; and
 - (ii) Matrimonial Case No 44 of 2021 titled “Amit Chauhan Vs Arti” from the Court of Principal Judge, Family Court at Mainpuri, Uttar Pradesh to the competent Court at Valsad, Gujarat
- 2 We have heard learned counsel for the parties.

3 Having regard to the interests of justice, we are of the view that an order for the
transfer of the proceedings is warranted. We direct that the following
proceedings be transferred to the Family Court at Ahmedabad:

(i) Matrimonial Case No 469 of 2019 pending before the Court of Principal
Judge, Family Court at Mainpuri, Uttar Pradesh; and

(ii) Matrimonial Case No 44 of 2021 pending before the Court of Principal
Judge, Family Court at Mainpuri, Uttar Pradesh.

4 The transfer petitions are accordingly disposed of.

5 The transferor court shall forthwith transmit the record of the aforesaid case to
the transferee court.

6 After transfer of the petition, the transferee Court is directed to make all
endeavour either for amicable settlement or for early decision in the matter
without unnecessary adjournments.

7 Pending application, if any, stands disposed of.
