SLP(C) No. 7619/2021

Ld. counsel appearing for respondent Nos.1, 2, 4, 7 and
9 to 11 submits that they have filed counter affidavit.

The office report indicates that service is complete on
respondent Nos.3, 5, 6, 8 and 12 but none has entered

appearance on their behalf. However, Ld. Advocate, Mr. Gopal Jha submits that vakalatnama on behalf of respondent No.12 - State was filed on 30.9.2021, but the office report does not reflect the same, and as such, Ld. counsel prays for four weeks' time to file their counter affidavit. The submission of Mr. Gopal Jha is taken on record. Registry may ascertain the facts and if respondent No.12 has filed vakalatnama, they are granted four weeks' time, as final opportunity, to file their counter affidavit.
