From the prosecution version it is difficult to say that the appellant shared common intention to kill the deceased. Sharing of knowledge of the occurrence is not ruled out. There was a quarrel with regard to the money transaction which led to causing of fatal blow by the co-accused who was a juvenile.

Accordingly, we hold the appellant guilty under Section 304 Part-II of the I.P.C. The appellant is sentenced to the period already undergone by him. The appellant is in custody. He may be released forthwith unless required in any other case.

The appeal is accordingly disposed of.
