O R D E R

IA No. 195064/2022 in SLP(C) No. 2977/2022

This application has been made by the petitioner seeking a direction to command the respondents to release the original high school and intermediate marksheet and other certificates of the

applicant being withheld by the petitioner no. 3 in the SLP i.e. The Government Medical College Haldwani.

We have heard learned counsel for the parties.

The dispute is pending adjudication in the present proceedings before this Court with respect to the question as to whether any condition for serving in the hilly area can be imposed upon the candidates who are allotted seats under All India Quota and whether any bond can be obtained from them for this purpose.

During the pendency of this dispute we see no good ground for the petitioner no. 3 Government Medical College to withhold the certificates of the petitioner.

Considering the above facts, let the original High-school intermediate marksheet and other certificates of the applicant-respondent be released forthwith.

In so far as the other prayer made in the application regarding issuance of no objection certificate for the purpose of securing regular admission in PG course is concerned, we direct that the admission given to the appellant in the PG course shall not be canceled solely on account of non-production of the No Objection certificate.

IA stands disposed of.
