SPECIAL LEAVE PETITION(CIVIL) No. 19583/2013:-

We have heard Mr. Sanjeev Sen, learned Senior counsel appearing for the petitioner - Vinayak R.D.P. Loundo - tenant.

After having heard the learned Senior counsel appearing for the petitioner - tenant and carefully perusing the material available on record, we find no reason to interfere with the impugned order passed by the High Court of Bombay so far as it rejected the contention of the petitioner herein as to the applicability of Article 137 of the Limitation Act and the effect of non-joinder of the legal heirs of the original tenant.

Accordingly, the Special Leave Petition stands dismissed.

We have heard the learned Senior counsel appearing for the parties.

After carefully perusing the material available on record, we find that it was not appropriate on the part of the High Court to quash and set aside the well reasoned Judgment dated 21-3-2011 of

the learned Tribunal, dismissing the Eviction Appeal No.10/2007 filed by the respondent (tenant) - herein, with a direction to the said Tribunal to decide the appeal afresh after hearing the parties in the light of the observations made therein.

Thus, we set aside the impugned Judgment of the High Court.

As a consequence thereof, the appellants are at liberty to take steps in accordance with the provisions of law.

The Appeal is allowed in the afore-stated terms.
