O R D E R

1. Applications for intervention/impleadment are allowed.
2. Arising out of the judgment dated 11.12.2017 passed by the learned Single Judge of the High Court directing the Director of the Education to decide the representation in terms of the observations made in the order, the present appeals have been filed.
3. Having considered the submissions of the parties and taking note of the fact that the issue of payment of the UGC Scale is to be decided by the Director of Education in terms of the order. The said order is merely in the nature of remand; however, we are not inclined to entertain the present appeals.
4. In this view, let the decision be taken by the Director of Education in accordance with law within a period of three months. On taking such decision, parties are at liberty to

take recourse as permissible. All the contentions are left open for them to be raised at appropriate stage. The directions as issued in this case shall apply *mutatis mutandis* to intervenors also.

5. Accordingly, the appeals stand disposed of. Pending applications, if any, shall also stand disposed of.
