Permission to file the Special Leave Petition is granted.

Applications for intervention/impleadment are allowed.

In para no.20 of the order presently under appeal, the High Court observed as under:

“Pending notice, the operation and effect of impugned order dated 3.6.2020 passed in Writ Petition No.8056 (SS) of 2020, *Rishabh Mishra & Others v. State of U.P. & Others* and other connected writ petitions, shall remain stayed, until further orders of this Court. However, the State Government is at liberty to proceed further in terms of Apex Court’s Order dated 21.5.2020 passed in

**Special Leave Petition (Civil) Diary No.11198 of 2020, Ram Sharan Maurya & Others v. State of U.P. & Ors. And order dated 9.6.2020 passed in Special Leave to Appeal (C) No.6687 of 2020, Subedar Singh & Ors. v. The State of Uttar Pradesh."**

Since the present Special Leave Petitions arise out of the interim order, we see no reason to interfere. These Special Leave Petitions are, accordingly, dismissed.

However, we request the Division Bench of the High Court to dispose of the pending appeals as early as possible and preferably within two months from today.
