Despite service, none has appeared for the respondent. The respondent is proceeded *ex parte*.

Having given due consideration to the contentions raised by the petitioner and the averments made in the transfer petition, and in the interest of justice, the transfer petition is allowed.

Accordingly, the Divorce Petition No. DMC/1399/2019 titled "*Hardeep Singh vs. Sonam*" pending before the Additional Principal Judge, Family Court, Jalandhar, Punjab is directed to be transferred to the Court of the Principal Judge, Family Court, District Central, Tis Hazari Courts, Delhi, who may hear the matter himself or assign it to a court of competent jurisdiction.

The parties may explore the possibility of settlement through mediation. The transferee court would obtain the desire and wishes of the parties and proceed accordingly in this regard.

The transferee court would decide the matter expeditiously.
