It is reported that the National Dam Safety Authority (NDSA) has been established and State Dam Safety Organisation (SDSO) has been established for specified dams falling under the jurisdiction of the Dam Safety Authority as specified under Section 24 (1) of the Dam Safety Act, 2021. It is submitted that therefore the SDSO can decide the issues in the present Writ petitions.
