UPON hearing the counsel the Court made the following
O R D E R

In terms of the previous order(s), the Municipal Corporation, Faridabad (for short 'the Corporation') is expected to complete the removal of unauthorized structures standing on forest land before 23.08.2021. The matters, therefore, be notified on 25.08.2021.

Before that date, the Commissioner may submit further status report. The status report may include the issue raised today by Mr. Colin Gonsalves, learned senior counsel, that the outcome of the representations to be made to the Commissioner may also be indicated briefly in the status report.

The learned counsel for the Corporation has apprised us that the draft policy has been submitted to the State Government for its approval. That consideration be expedited by the State Government and final decision be taken preferably before the next date of hearing.

Further, to assuage the grievances of the locals and to enable them to avail of option made available to them in terms of the previous order(s), the Commissioner may specify an e-mail address for online correspondence and also consider of setting up back-up office in the Radha Swami Complex, where the concerned persons have been provided temporary food, shelter and accommodation.

Advocate on record for the Corporation/State must ensure that the documents filed in the leading case i.e., SLP(C) Nos.7220-7221/2017 be also served on the advocate(s)-on-record for the petitioner(s)/applicant(s) in the companion cases.

In the meantime, the applicants are free to present material/representation before the competent authority, who has issued notice for removal of allegedly unauthorized structures, by tomorrow i.e., 4th August, 2021 by 12.00 noon, which can be considered by the authority appropriately.

If the competent authority is of the firm opinion formed on the basis of official record that the concerned structures, referred to in the show cause notice issued to the applicants, are standing on the forest land, the competent authority would be free to proceed in the matter in accordance with the directions already issued earlier by this Court in the leading case from time to time.

However, if it is not a forest land, the competent authority must abide by the protection given to the structures by this Court in the civil appeals referred to above, till Friday i.e., 6th August, 2021.
