UPON hearing the counsel the Court made the following
O R D E R

We have perused our earlier orders dated 12th September, 2023 and 12th December, 2023. We have perused the affidavit filed by the

I.I.T. (Delhi) expressing several difficulties why the I.I.T. (Delhi) till date could not comply with the orders of this Court. I.I.T. (Delhi) perhaps wants some other agencies to be appointed to assist it. We, therefore, permit I.I.T. (Delhi) to engage agencies of their choice to assist for the purposes of making compliance with the orders of this Court. The charges payable to the agencies shall be communicated to the Municipal Corporation, Faridabad. The Municipal Corporation shall pay the requisite charges as per the bills and invoices submitted by the I.I.T. (Delhi).

We do not think that I.I.T. (Delhi) is prevented from carrying out the work assigned to it on the ground that several documents sought by it have not been supplied.

We hope and trust that I.I.T. (Delhi) will note the urgency and complete the assignment given to it at the earliest. The I.I.T. (Delhi) will note that the issue is of rehabilitating several families. We finally grant time to I.I.T. (Delhi) to complete the exercise till 12th July, 2024.

I.I.T. (Delhi) will submit a report within a period of one week from 12th May, 2024 to the Municipal Corporation. The learned Advocate for the Corporation will supply copies thereof to the learned counsel appearing for the parties and place the original report on record.
