UPON hearing the counsel the Court made the following
O R D E R

Firstly, taking note of issue of non-payment of *solatium* to 245 persons, we direct the Commissioner of petitioner-Corporation to remain present before this Court either personally or through video conference on 18th October, 2024. *Prima facie*, we do not see any reason why *solatium* should not be paid to 245 persons.

In the meanwhile, it will be open for the commissioner to file his personal affidavit dealing with the issue of *solatium* to 245 persons.

We have perused the application filed by IIT (Delhi). We direct the Municipal Corporation, Faridabad to conclude the negotiations with M/s Roadic Consultants Private Limited and issue them order of appointment/work order as desired by IIT (Delhi). This order shall to be complied with within a period of two weeks from today. IIT (Delhi) will submit a detailed time schedule for completing the assessment of habitability of 1072 flats before the next date.
