O R D E R

Heard learned counsel for the parties.

There are three proceedings pending between the parties, of which one has been filed by the husband for restitution of conjugal rights and the other two proceedings have been filed by the wife, respectively, for dissolution of marriage and for domestic

violence.

This Court deems it appropriate to refer the matters to the Supreme Court Mediation Centre.

Considering the distance between New Delhi and the places where the parties are now residing, the Supreme Court Mediation Centre shall initiate mediation talks through video-conferencing, to begin with.

The Supreme Court Mediation shall nominate a Mediator, who has knowledge of Kannada Language so that the parties are at ease.

The parties are directed to appear before the Supreme Court Mediation Centre on 22.08.2022 at 11 A.M.

To enable the Supreme Court Mediation Centre to set up the first meeting through video-conferencing and provide link of the meeting to both the parties, learned counsel for both the parties shall file a memo within two days from today indicating the mobile phone numbers and the e-mail ids of their respective parties.

The Registry is directed to forward the papers relating to the transfer petition to the Supreme Court Mediation Centre.
