O R D E R

I.A. No. 79013/2025:

We have heard learned counsel for petitioner No.1 and
learned counsel for the respondent-State.

An application has been filed by petitioner No.1 seeking interim bail as his son is getting married on 20.04.2025 and he is required to be present in the pre-marriage rituals and thereafter also.

In the circumstances, we direct that the petitioner No.1 be produced before the concerned Sessions Court on 11.04.2025 and subject to the terms and conditions to be imposed by the concerned Sessions Court, the petitioner No.1 shall be released on interim bail for the period from 11.04.2025 to 25.04.2025. The petitioner No.1 shall surrender on 25.04.2025.

In case, the petitioner No.1 fails to surrender, the police concerned shall ensure that he is arrested and lodged in prison.

The application is allowed in the aforesaid terms.
