The present petition has been filed by the petitioner-wife seeking transfer of D.O.P.No.403 of 2019 titled "Richardson Antony vs. Suma Saravanan & Anr." (subject-case) pending in the Family Court at Coimbatore, Tamil Nadu to the Principal Judge, Family Court at Bengaluru, Karnataka.

Heard learned counsel for the petitioner. No one appeared on behalf of the respondent in spite of service of notice but as per office report dated 07.12.2022, the respondent had sent emails on 18.02.2022 and 28.09.2022 stating therein that he has no objection to transfer the subject-case to Bengaluru.

Considering the materials disclosed, in our opinion it would be expedient for the ends of justice to transfer the subject-case to the Court asked for by the petitioner.
