IN SLP(CRL.) NO. 3237/2020

The application for direction has been filed arising from the settlement deed/MOU arrived at inter se the parties on 08.11.2021.

The parties have also obtained a mutual consent divorce in terms of the judgment of the Principal Judge Family Court, Patiala House Courts, New Delhi, on 14.03.2022.

The orders which are now being sought from this Court to quash the proceedings emanating from FIR No. 114/2012 dated 19.04.2012 registered at P.S. Mukherjee Nagar, Delhi which had been stayed in the meantime by this Court and also to quash complaint being CC No. 18323/2017 on the file of MM, South-West Dwarka, Delhi.

In view of what is stated in the application and which is duly supported by the affidavit and in the presence of respondent No. 2, proceedings in pursuance to the aforesaid FIR are quashed. The complaint being CC No. 18323/2017 on the file of MM, South-West Dwarka, Delhi shall also stand

quashed.
