**UPON hearing the counsel the Court made the following
O R D E R**

1. The learned senior counsel/counsel for the State of Haryana, Govt. of Nct of Delhi, Central Pollution Control Board (CPCB) are present and state that they have submitted their respective Status Reports, pursuant to the order passed by this Court on 08.08.2023.
2. Let the copy thereof be furnished to the learned counsel, Ms. Vanshaja Shukla, who is assisting the learned senior counsel, Ms. Meenakshi Arora, an Amicus Curiae in this case.
3. As per the order dated 08.08.2023, this Court had deemed it appropriate to first hear the issue relating to the pollution of the Yamuna River. Since the Status Reports have been filed by the

State of Haryana, as also by the Government of NCT of Delhi and CPCB, list the matter on 27.02.2024 for consideration of the said issue.

4. In the meantime, the authorities may file their Status Reports, if not filed so far, pertaining to the other issues.
