Heard Ms. Amita Singh Kalkal, learned counsel for the petitioner and Dr. Nirmal Chopra, learned counsel appearing on behalf of the respondent.

The learned counsel for the respondent has not objected for transfer of H.M.A. No. 1182 of 2019 titled as "*Mahesh Sharma vs. Hemlata*" pending before the Court of Principal Judge, Family Court, Yamuna Nagar, at Jagadhri, Haryana to the Family Court, Haridwar, Uttarakhand, but has made a request that the maintenance case pending before the Family Court, Haridwar titled as "*Hemlatha vs. Mahesh Kumar*" and the divorce petition may be heard analogously and if possible same date may be fixed for both the cases and also the case be decided as early as possible. The said prayer is not opposed by the other side.

Considering the aforesaid by the consent of the parties, H.M.A. No. 1182 of 2019 titled as "*Mahesh Sharma vs. Hemlata*" is transferred from the Court of Principal Judge, Family Court, Yamuna Nagar, at Jagadhri, Haryana to the Family Court, Haridwar, Uttarakhand.

The transfer petition is, accordingly, allowed with a request to the Family Court, Haridwar to list both the cases for analogous hearing and fix a same date, if possible and decide the same as early as possible.

Let a copy of this order be sent to the concerned Courts.

Records pertaining to H.M.A. No. 1182 of 2019 shall be transferred forthwith to the transferee Court.
