The Writ Petition alongwith application for directions (I.A. No.1) above-mentioned was listed before the Hon'ble Court on 02.05.2016, when the Court was pleased to pass the following order:

"Issue notice.

We make it clear that selection finalised in the proceedings dated 8th April, 2016 shall be proceeded with and the same shall not in anyway be affected by issuance of notice in this writ petition."

It is submitted that pursuant to the aforesaid order, show cause notice was issued to all the 14 respondents through Regd. A.D. on 12.05.2016. M/s Parekh & Co., Advocates have on 03.06.2016 filed vakalatnama on behalf of Respondent Nos. 1 & 5 viz. High Court of Judicature Patna but counter affidavit has not been filed so far.

It is further submitted that Mr. Deepak Goel and Mr. Anup Kumar has on 05.05.16 and 01.07.16 filed application of Impleadment which have been registered as I.A. 2 & 3 respectively and Mr. Ratnesh Kumar Shukla, Advocates has on 28.06.16 filed application for intervention and the same has been registered as I.A. Nos.4. (copy of the same included in Paper books.)

It is lastly submitted that M/s. Amit Pawan & Deepak Goel, Advocates has on 25.07.16 and 14.07.16 filed applications for Intervention & Impleadment and the same have been registered as I.A. Nos. 7 & 8 respectively. (Copy of the same placed with paperbooks of Writ Petition.)

Service of notice is not complete on Respondent Nos. 6 to 14.

The applications in the Writ Petition above mentioned are listed before the Court of Hon'ble Judge-in-Chamber with this Office Report.
