Ld. Counsel appearing for respondent Nos.10, 12, 46 and 55 prays for and is granted two weeks' time to file their counter affidavit. Ld. Counsel for the petitioner is directed to submit proof of service of pleadings upon the said respondents in the course of the day.

Ld. counsel appearing for respondent Nos.2 and 3-State prays for extension of time for filing counter affidavit. Records show that respondent Nos.2 and 3 have not filed counter affidavit, despite grant of final opportunity on an earlier occasion. Accordingly, the prayer is refused.
