This transfer petition has been filed by the petitioner-wife under Section 25 of the Code of Civil Procedure, 1908 seeking transfer of case bearing Family Main Case No.136 of 2019, titled as "*Pawan Lodha vs. Sonam Singh*", from the Court of the Additional District and Sessions Judge, Nathdwara to the Court of Competent Jurisdiction at Jabalpur, Madhya Pradesh.

2. Heard learned counsel for the parties and perused the material placed on record.
